Use 1-2 quarts/acre. Banded, broadcast, or irrigation application is acceptable. Although compatible with most pesticides and nutrients, a jar test is recommended. Otherwise, consult your SummitGold technical representative. *Shake well before using.* 

## SUGGESTED APPLICATION

### Row Crops:

1-2 quarts/acre in-furrow on Corn, Soybeans, Peanuts, Cotton, etc. or spray 1-2 quarts/acre to soil at or near planting on surface or side banded. May also be used with side-dressed plant food.

## COMPATIBILITY

**Retrieve** is compatible with most common foliar liquid nutrients and micronutrients; however, USER ASSUMES FULL RESPONSIBILITY to ensure compatibility when tank mixing with other products.
