### GENERAL DIRECTIONS FOR USE:

SG Advance is used at 2-4 quarts per acre. Apply by water run (flood or sprinkler), spray (air or ground), or injected into fertigation system.

### SUGGESTED APPLICATION

**Row Crops:** 2-4 qt in 5-15 gal water per acre foliar spray on Corn, Soybeans, Alfalfa, etc. For best results application should be made when air temp is below 80° and humidity is below 80%. Product is typically rain fast once it dries on leaf surface.

Do not apply this product when plants are under severe stress
