GENERAL DIRECTIONS FOR USE:

Use 1 pint / acre for impregnation on dry fertilizer or apply by water run (flood or sprinkler), spray (air or ground), injected into fertigation system. **Shake well before using.**

SUGGESTED APPLICATION

Specialty Crops:

1 pint / acre on Potatoes, Sugar Beets, Sweet Potatoes, etc.

Impregnate on dry fertilizer or spray or fertigate 1 pint per acre to soil at or near planting on surface or side banded. May also be used with side dressed plant food.

Small Grains:

1 pint / acre: Impregnate on dry fertilizer or apply at planting with drill or 1 pint / acre sprayed to soil at planting or near dormancy break or apply through fertigation.

COMPATIBILITY

SG Complete SW is compatible with most common foliar liquid nutrients and micronutrients; however, **USER ASSUMES FULL RESPONSIBILITY** to ensure compatibility when tank mixing with other products.

Do not mix or apply with fungicides. Do not mix with other components without a compatibility test. An adequate test for compatibility involves mixing in a small container the proper proportions of the product with water and the other ingredients.
