Use 1-4 pints/acre. Banded (do not apply on seed), broadcast, or irrigation application is acceptable. Although compatible with most pesticides and nutrients, a jar test is recommended. Otherwise, consult your SummitGold technical representative. **Shake well before using.**

SUGGESTED APPLICATION

Row Crops, Turf, Tree & Vine Crops:

Foliar: 1-4 pints/acre foliar per application. Burning may occur if more than 4 pints/acre is applied in low volume sprays or with large droplet sizing.

Soil Application: 1-4 pints/acre to soil at or near planting on surface or side banded. May also be used with side-dressed plant food.

Do not use as a pop up or seed application

COMPATIBILITY

SGE Boron is compatible with most common foliar liquid nutrients and micronutrients; however, **USER ASSUMES FULL RESPONSIBILITY** to ensure compatibility when tank mixing with other products.

Do not mix with other components without a compatibility test. An adequate test for compatibility involves mixing in a small container the proper proportions of the product with water and the other ingredients.
