## PURPOSE AND GENERAL DIRECTIONS FOR USE: SG

Elements is a liquid nutrient product that is designed to provide nutrients that may be deficient in the soil or plant. Use 1-2 pints/acre by banding, broadcast, or irrigation application. Although compatible with most pesticides and nutrients, a jar test is recommended. Otherwise, consult your SummitGold technical representative. **Shake well before using.**

## SUGGESTED APPLICATION

### Row Crops, Turf, Tree & Vine Crops:

**Foliar:** 1-2 pints/acre foliar per application. *Burning may occur if more than 1 quart/acre is applied in low volume sprays or with large droplet sizing.*

**Soil Application:** 1-2 quarts/acre to soil at or near planting on surface or side banded. May also be used with side-dressed plant food.

## COMPATIBILITY

**SG Elements** is compatible with most common foliar liquid nutrients and micronutrients; however, **USER ASSUMES FULL RESPONSIBILITY** to ensure compatibility when tank mixing with other products.

Do not mix with other components without a compatibility test. An adequate test for compatibility involves mixing in a small container the proper proportions of the product with water and the other ingredients.
