GENERAL INFORMATION

SG Hydr8-R is a soil or foliar applied liquid zinc product designed for zinc deficiencies in plants. It also contains soil surfactants that will help increase water penetration. SG Hydr8-R can be used in agricultural, ornamental and turf applications.

SG Hydr8-R can be applied by irrigation (flood-drip-sprinkler-etc), spray (air or ground), injected into fertigation system, or shanked in with or without other nutrients. Although compatible with most pesticides and nutrients, a jar test is recommended. Otherwise, consult your SummitGold technical representative.

STORAGE AND HANDLING: Store in a sealed container in a cool dry place, out of direct sunlight. Store at temperatures above 40 degrees F and below 95 degrees F. Product must be used within 15 days after opening for maximum efficacy. Use within 36 hours of mixing.

GENERAL DIRECTIONS FOR USE:

Soil Rates: Apply SG Hydr8-R at 1-2 pints per acre every week for a 5 week period followed by 1-2 pints per acre every month throughout growing season.

New Crop: Apply 1-2 pints per acre of SG-Hydr8-R just prior, at or just after planting.

Foliar Spray: Add 2-4 ounces of SG Hydr8-R in a tank mix with various fertilizers, micronutrients and non selective herbicides to improve foliar uptake into plant.

NOTES: Do not apply with selective herbicides. SG Hydr8-R may increase nutrient uptake. It is recommended that you reduce fertilizer and pesticide rates by 5-10% until you determine it's impact on uptake and phytotoxicity. SG Hydr8-R is compatible with most common foliar liquid nutrients and micronutrients; however, USER ASSUMES FULL RESPONSIBILITY to ensure compatibility when tank mixing with other products. An adequate test for compatibility involves mixing in a small container the proper proportions of the product with water and the other ingredients. **Shake well before using**
