SUGGESTED APPLICATION

Row Crops:

1 gallon / acre sprayed as a foliar on Corn, Soybeans, Peanuts, Cotton, etc. or spray 1/2 gallon a minimum of 2 times per crop. May also be used as a soil applied additive to fertilizer solutions.

COMPATIBILITY

Shift is compatible with most common foliar liquid nutrients and micronutrients; however, **USER ASSUMES FULL RESPONSIBILITY** to ensure compatibility when tank mixing with other products.
